TERMS for participants



Multilevel's site consists of multiple activities; **Ziplines** where you are hanging in a harness under a wire, travelling at high speeds. In one of the Ziplines, you can ride in a wheelchair.

High ropes courses in which you climb at high level through different challenges/obstacles between trees. A **climbing tree** in which you climb up to 10 meters high and let go of your grip or climb back down.

All activities have well developed safety systems that ensure controlled slowdowns and soften possible falls. Despite the safety systems, shakes/twitches and other strains to your body can happen.

We discourage people with any of the following characteristiscs to participate in the activities:

- People with **back or neck related conditions** that can be worsened in the event of a fall or when safetysystems kick in.
- People who are **pregnant**.

If you have conditions like diabetes, epilepsy, heart related conditions, serious allergies etc, that can affect your possibilites to perform the activities safely, inform a instructor prior to entering the site and what the instructor can benefit from knowing in case help is needed. *Please check applicable box below:*

I confirm the following:

- I have/will participate in the safetytraining provided on site and have been approved to perform the activities. (This training is excluded if the ziplineride in wheelchair is the only activity performed)
- I confirm that I/we at all times can understand and need to follow instructors' guidance.
- My total weight is between 20kg (44 lbs) up to 120kg (264lbs) at the time when I perform the activities which includes provided personal protection equipment of 3 kg (7 lbs) and includes a wheelchair (if applicable) that weighs maximum 20kg (44 lbs). I understand that I cannot participate if I weigh in too light or too heavy. Everyone will be weighed.
- My personal protection equipment will be put on and taken off at the same place. If I handle the equipment carelessly, I might need to pay a fine of appr 500Euro or equivalent in USD or SEK)
- I am not under the influence of alcohol or drugs.
- I do not carry any loose items e.g. cellphone, keys etc. I have taken off jewelry, rings, necklaces, watches, and similar.
- My long hair is set safely and I wear no loose textiles e.g. shawls, plaids or similar.
- I understand that I might come in contact with surfaces that can give abrasions, stains on skin, and can destroy clothes and shoes e.g tree-resin or oils from construction parts etc.
- I do my visit to the bathroom without harness.
- I smoke only without harness and only on the graveled area in the parking lot. I collect my butt-ends safely.
- I approve that Multilevel can use photos/videos of me and people in my company for commercial purposes.
- I have informed an instructor of special conditions e.g. diabetes, epilepsy, heartrelated issues etc.
- I understand that an instructor has the right to stop any activity if rules are not followed or if it is judged not safe to continue the activities e.g. due to lightning, heavy precipitation, storms, strong winds or any other reason.

If any of the accompanying participants are **below 11 years of age** (=minor), I also agree to the following:

- At least one adult is joining in the activity and is responsible for the safety of the minor (-s).
- I as an adult can have maximum three minors accompanying me.

I as an adult approve participants **between 12-17 years** to perform the activities.
